You should report it to Nintendo at the support@nintendo.com. On a side note, this website is really poor and outdated. They do not explain well why what they offer is so good and free, and they are very unclear about the site being filled with malware. It's really annoying that they store your private information on this website, and making it nearly impossible to delete their cookies. The main problem is that there is a binary file in their site, which is a Windows executable that tries to open a HTTPS connection to another HTTPS server, in an attempt to detect the web browser and tell the owner of the browser about it. This is stupid because this can only be done when the browser is open, and even then only if the website is opened in the browser that wants to do it, and if it's a HTTPS website. Even if the website is in a different language and it's not in English, it is not legitimate to ask to activate the browser in order to read the website. The executable is used to detect other versions of the website, which is not useful for the game you're playing.

Prior to trial he pleaded guilty to possessing a controlled substance with intent to distribute, in violation of Utah Code Ann. § 58-37-8(2)(a)(i). The presentence report showed that at the time of his arrest, Lund was carrying a quantity of methamphetamine and other drugs, a sizeable sum of money, and a large quantity of ammunition. Lund argued that he had not been offered a binding plea agreement, and that he should have been allowed to withdraw his guilty plea. The trial court denied the motion. Lund had been arrested in North Carolina in April 1989, had been indicted in North Carolina in October 1989, had pleaded guilty in February 1990, and had served his sentence.
